

**CELINE DION SPOTIFY CONTEST  
OFFICIAL TERMS AND CONDITIONS**

**Territory: (Hong Kong, Singapore, Indonesia, Philippines, Taiwan, Thailand)**

**1. Eligibility**

- 1.1 By entering the Contest, you agree that you have read and understood these Official Rules and agree that you will be bound by them.
