

AUTHORIZATION AND RELEASE

IMPORTANT: BY SIGNING THIS AUTHORIZATION AND RELEASE (THE "RELEASE") YOU ARE AGREEING TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT SIGN THIS RELEASE.

I hereby submit this Release to Sony Music Entertainment ("SME"), with the understanding that it will be relied upon to confirm my eligibility to attend a Wyclef Jean special event (the "Event").

I, the undersigned, for and in consideration of the premises and obligations contained herein and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, hereby agree as follows:

1. I authorize SME to photograph, videotape, audiotape, and otherwise record my name, image, caricature, silhouette, likeness, voice, biographical material, and oral and written statements (collectively, my "Likeness"), to reproduce, use and publish, in its sole discretion, works, recordings, and photographs containing any part of my Likeness made by or on behalf of SME, including, without limitation, any video recorded in connection with the Event, and any edited, revised, or modified versions thereof (collectively, "Materials") for purposes of advertising, exhibition, distribution, broadcast, or any other dissemination in any and all media anywhere at any time without limitation without further compensation to me.
2. I understand and agree that I do not and shall not have any rights, including without limitation, trademark rights, copyright rights, or publicity rights, to the Materials or any portion thereof, and I therefore shall have no right of approval over the creation, development, manufacture, promotion, distribution, display, or sale of the Materials or contents of the Materials or the manner of use or exploitation of the Materials or my Likeness.
3. I represent to the best of my knowledge (or that which I should know in the exercise of reasonable diligence or prudence) that the consent of no other person, firm, corporation, or labor organization is required to enable SME to use my Likeness or the Materials as described herein, and that such use(s) will not violate the rights of any third parties.
4. I hereby release SME from, and shall neither sue nor bring any proceeding against SME for any liability, loss, demands, claims, or causes of action for defamation, invasion, or other violations of rights to privacy, publicity, or personality in connection with my participation to the Materials or otherwise in connection with SME. I hereby waive any protections afforded by any applicable statute or law in any jurisdiction whose purpose, substance, and/or effect is to provide that a general release shall not extend to claims, material, or otherwise which the person giving the release does not know or suspect to exist at the time of executing the release. This may mean that I am releasing unknown future

claims. I agree to indemnify, defend, and hold harmless SME from and against any and all losses, damages, liabilities, penalties, costs of settlement, and expenses (including, without limitation, reasonable attorney's fees and expenses) arising from any third-party claims, suits, proceedings, demands, or causes of action (including, without limitation, governmental actions) arising out of, resulting from, or relating to my involvement with SME.

5. I, for myself, my heirs, personal representatives, or assignees, do hereby agree and hold SME, together with its parent companies, subsidiaries, affiliates, officers, directors, employees and agents or advertising or promotion agencies, and their respective affiliates, officers, directors, employees, agents, licensees, assignees, contractors, and representatives, harmless and release, waive, discharge from liability and covenant not to sue against for any and all liability, personal injury, death, hijacking, kidnapping, or other injury, accident, illnesses, property loss, or damages, or from any and all other claims including negligence of the aforementioned parties arising from my participation in the Event, Materials or otherwise in connection with SME, including, but not limited to, if applicable: (a) my travel to and from the Event location; (b) my stay at the same; (c) any and all activities I engage in while there; and (d) my participation in the Materials and/or the Event. SME will not obtain insurance on my behalf, and I am fully responsible for obtaining such insurance, should I desire it.
6. I agree that money damages would not be a sufficient remedy for any breach of my obligations herein and that SME will be entitled to injunctive or other equitable relief to remedy or prevent any breach or threatened breach of these terms by myself or any of my agents. Such remedy will not be the exclusive remedy for any breach hereof, but shall be in addition to all other rights and remedies available at law or in equity.
7. If any part of these terms shall be adjudged by a court of competent jurisdiction to be invalid, such judgment will not affect the remainder of these terms, which will continue in full force and effect.
8. No failure or delay by SME in exercising any right, power or privilege shall operate as a waiver thereof, nor shall any single or partial exercise thereof preclude any other or further exercise thereof, or the exercise of any other right, power or privilege hereunder.
9. I acknowledge that the courts located in New York, NY, will have sole and exclusive jurisdiction over any action or proceeding regarding this Release and irrevocably consent to the jurisdiction of such courts.

By signing below, I represent and warrant that: (i) I have I have read and fully understand the contents and implications of this Release; (ii) I am at least twenty-one years of age as of [insert date of email invitation] and have attached hereto a photocopy of my government-issued photo ID; and (iii) I am a legal resident of the state of New York, New Jersey, Pennsylvania, or Connecticut. I affirm and represent that I have complied with all the requirements listed in the invitation, and that I have committed no fraud or deception in attending the Event or claiming an invitation.

Further, I agree that I will not be eligible to attend the Event if any statement made by me in this Release is false.
